e-Safety and Acceptable Use Policy

1. Introduction

ND SEND Specialists Ltd (NDSENDS) is committed to ensuring the safe and responsible use of digital technology when working with children and young people (CYP), families, and education providers. This policy sets out guidelines for acceptable use of digital devices, online communication, and safeguarding measures to protect CYP and uphold professional standards.

2. Purpose

This policy aims to:

- Protect CYP from risks associated with online activity.
- Ensure appropriate and professional digital communication.
- Minimise risks related to data protection and cybersecurity.
- Provide clear guidelines on acceptable use of technology.

3. Scope

This policy applies to:

- The director of NDSENDS (as the sole provider).
- CYP, families, and educational professionals engaging with NDSENDS via digital platforms.
- The use of company-owned and personal devices when conducting business activities.

4. E-Safety Principles

ND SEND Specialists Ltd follows key principles to ensure a safe digital environment:

- Safeguarding First Prioritising the online safety of CYP in all digital interactions.
- **Data Protection** Ensuring compliance with GDPR when handling personal and sensitive information.
- Appropriate Communication Maintaining professional and respectful interactions online.
- Cybersecurity Taking measures to protect against cyber threats and online risks.





5. Acceptable Use Guidelines

5.1 Use of Technology

- All technology (including personal and work devices) used for NDSENDS activities must be secure and protected with strong passwords.
- Digital communication (emails, video calls, messaging apps) must be professional, appropriate, and safeguarding-compliant.
- Devices used for NDSENDS business should have up-to-date security software and antivirus protection.

5.2 Online Communication with CYP

- Direct one-to-one online communication with CYP should be limited and take place only when necessary for learning or support purposes.
- Where possible, a parent, guardian, or another responsible adult should be included in digital communication with CYP.
- Video calls should be conducted using approved and secure platforms, with appropriate safeguarding measures in place.
- No personal contact details (phone number, personal email, or social media) should be shared with CYP.

5.3 Social Media and Digital Conduct

- The director of NDSENDS will maintain a professional online presence and avoid engaging in personal interactions with CYP via social media.
- Any online content shared must be appropriate, professional, and aligned with safeguarding responsibilities.
- Cyberbullying, inappropriate content sharing, or online harassment will not be tolerated.
- Parents and CYP will be encouraged to practice responsible social media use.

5.4 Data Protection and Confidentiality

- All personal information about CYP and families must be securely stored and shared only when necessary, in line with GDPR regulations.
- Personal data should never be stored on unsecured devices or shared via unsecured platforms.
- Any data breaches must be reported and managed in line with data protection policies.



6. Online Safety Risks and Mitigation

7. Reporting Concerns

Any e-safety concerns, including inappropriate content, online abuse, or breaches of security, should be reported immediately to the **relevant safeguarding authorities** or **the school's Designated Safeguarding Lead (DSL)** when working within a school setting.

8. Policy Review

This policy will be reviewed annually to reflect updates in safeguarding, technology, and GDPR regulations.


